- TSXV Daily Trading Summary: Covers TSX Venture Exchange (including NEX). NEX and debentures included on and after Oct. 3, 2013. History in current record layout available back to Sept. 23, 2013. History available from March 9, 2009 to Sept. 20, 2013 in different record layout (see below).
- Alpha Daily Trading Summary: Covers Alpha trading. Released May 1, 2014. History available from Aug. 2, 2011.
