The file contains equity dividend payment details for those securities in the WSH database. The time period covered is based on record date and includes 30 days historical as well as all future payments.

Data is produced as a text file in XML version 1.0 encoding=ISO-8859-1 format. See individual format below for more details.

DATA FORMAT

We support the following data types:

Туре	Description
Char	This is a character field of varied length.
Date	This is a date in the format <i>m/d/yyyy</i> or blank (if no date is available)
Amount	Dollar amount to six decimal places (-0.000000). In U.S. dollars.
DateTime	This is a date and time string in the format <i>m/d/yyyy h:mm:ss AM/PM</i>

TIMING AND SCHEDULING

File is produced every three (3) hours beginning at 5:00am ET and ending at 11:00pm ET. Also, we run a 9:00am cycle to get you as up-to-date as possible before the stock market opens. On Saturdays, the 8:00am and 9:00am ET runs are bypassed to accommodate the 6:00am to 10:00am ET engineering maintenance window.

We suggest you pull the file(s) at 10 - 15 minutes past the hour and check the file date/time stamp against the previous file to ensure you will download an updated version of the file.

DELIVERY

Two options are available for file pickup: "Pull FTP" or "Push FTP". If you would like to pull your file(s) on demand, we will issue you FTP login credentials to our ftp server. Alternatively, you may issue us a login to your FTP server and we will push the file(s) to it.

RECORD FORMAT & DESCRIPTION

Field	Format	Usage
event_id	Char	WSH unique event identifier.
company_id	Char	WSH unique company identifier. To be used to group a company's records together if their ticker symbol has changed.
stock_symbol ¹	Char	This is the company's ticker symbol. A "CA:" prefix is used for companies WSH tracks as Canadian.
isin	Char	This is a unique security identifier.
company _name	Char	This is the name of the company.
stock_exchange	Char	See WSH Common Appendices document for stock exchange reference table.
approval_status	Char	Indicates if dividend is <i>Approved</i> by board, is <i>Pending</i> their approval, has been <i>Canceled</i> , or has been <i>Deleted</i> from coverage.
dividend_amount	Amount	Amount of dividend in US dollars. If converted to USD, exchange rate at time of entry is used.
dividend_oc	Amount	The amount of the dividend in the currency specified by dividend_currency
variable_flag	Char	"Y" indicates that a component of the dividend, or the entire dividend, is Variable.
variable_amount_oc	Amount	The amount of the variable component of the dividend
dividend_currency	Char	The 3-digit currency code the dividend amount was reported in. See <i>WSH Common Appendices</i> document for currency reference table.
mixed_dividend	Char	"Y" indicates that dividend amount is specified and will be a combination of cash and stock.
frequency	Char	Payment frequency of the announced dividend. ANNUAL, SEMI-ANNUAL, QUARTERLY, MONTHLY, SPECIAL, UNKNOWN
announce_datetime	DateTime	Date dividend was announced
ex_div_date	Date	The ex-dividend date
record_date	Date	Date before which holders-of-record will receive the dividend.
pay_date	Date	Date the dividend was paid
